SOW includes several activities: 1) Staff time to administer and promote well sealing with a goal of 10 wells sealed over the next two years. The goal is to seal 70 wells over the next 10 years and 2) Hiring of a technician to complete land protection activities. Isanti SWCD will put up the match.

a. Staff

Determan mentioned the date for appreciation dinner for everyone that has done projects with us be on August 27th Determan, Kozur and V. Anderson attended the day at the capital. Determan reviewed the Skogman Lake report. She went on to give an update of the Isanti County Comprehensive Plan noting that she is consulting with Emmons and Oliver via Lower St. Croix Partnership funding. Determan also mentioned the BWSR Soil Health Grant Application for new hire sharing with Chisago and Washington Counties focusing solely on Soil Health was funded.

Kulaf shared a video of Cartwright Wetland drone progression project. Kulaf working on more concept designs with other landowners that are interested in wetland projects. Kulaf working on Woods project and going out there during the week to see how it is coming along. Woods project should be done in two weeks if snow does not slow it down. Kulaf working with Fish and Wildlife on restoration projects. Kulaf also working with Dave to tie in some possible Lower St. Croix projects. Finally, Kulaf started learning how to use the survey equipment.

Remer attended CentraSota winter Ag event meeting in St. Cloud. Remer also attended the second outreach event with Rum River Watershed Partnership in Princeton with Sherburne and Mille Lacs Counties. Remer attended Farmer Led Group meeting yesterday. Remer is also working on several new RIM easements. Remer attending Ag lunch and learn next Tuesday, March 26th. Finally, Remer checking into pricing for new drill rental we will be getting in June or July 2024.

Gehrking noted that she provided administrative support as usual.

b. NRCS District Conservationist

A new District Conservationist will be starting next Monday at the Cambridge office. Twenty EQIP applications were approved for Isanti. NRCS is working with district on all EQIP plans to get Remer's planning certification and certified JAA. Steffen attended Rum River Watershed Partnership meeting in Milaca on March 11th.

c. County Commissioners

Berg was not present but provided an update: Comprehensive plan still under review, there will be an update at the Commissioner meeting on Tuesday, April 2nd. Isanti County Bauman family farm of the year celebration.

d. Committee Reports

Medvecky attended the MCD meeting on February 28th. MCD board approved to reduce 2024 Membership dues from \$1,600 to \$800. Recommendation was to contribute \$400 of dues reimbursed from MCD to be used towards the MN State Envirothon.

Next MCD meeting is August 28th. Medvecky also attended the Farmer Led group and they had a discussion on incentive rates for cover crops. The cover crop rates will be discussed further at the next board meeting and need a proposed plan for Isanti SWCD policy.
